## Allowable uses of STEP funds

STEP funds may be approved for export marketing-related activities for Fiscal Year 2017 solely for travel to preselected tradeshows. It will be a shared cost with eligible small business concern.

## Is your business eligible?

U.S. Virgin Islands businesses must meet the following criteria:

- 1. In operation for at least one year
- 2. In good standing with the U.S. Virgin Islands Internal Revenue Bureau
- 3. Demonstrates an understanding of the costs associated with exporting
- 4. Export products manufactured in the U.S. Virgin Islands
- 5. Willing to confidentially provide export sales data to the VIEDA for Federal reporting status
- 6. Are not presently debarred, suspended, proposed for debarment declared ineligible, or voluntarily excluded from covered transactions by any Federal department or agency.
